 - Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.
- 4. Interested bidders may obtain further information from the Provincial Government of Southern Leyte and inspect the Bidding Documents at the address given below during regular office hours.
- 5. A complete set of Bidding Documents may be acquired by interested Bidders on March 31, 2021 from the address payment of a non-refundable fee in the amount of Php 500.00 at the Provincial Treasury Services Office, this province. It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.
- 6. The Provincial Government of Southern Leyte will hold a **Pre-Bid Conference on April 8**, **2021** 10AM at Jose Rizal Hall, Provincial Capitol, Asuncion, Maasin City, and Southern Leyte which shall be open to prospective bidders.
